### **Site visitors**

However, we may automatically collect information about your visits, such as browsing patterns. Information collected in this way does not reveal your contact details or any type of Personal Data. This information is only used in aggregate form to analyse, manage and develop the GRASPIT website and is not linked to any individual.

### **Third Party**

Paypal is used as a 3rd party payment engine for products and services purchased through the GRASPIT website and their privacy policy is available upon request.

### **Legal requirements**

We reserve the right to access and disclose Personal Data to comply with applicable laws and lawful government requests or requests by the police investigating suspected illegal activities, to operate our systems properly or to protect ourselves or other GRASPIT website users.
